EXAMPLE:

Customer with 3/4" connection uses 20,000 gallons of water

Existing Rates -

Water rates x 2.45 (\$15.00 + 14,000 gallons x \$2.10/1000 gal.) x 2.45 = \$108.78 or minimum of \$78.00, whichever is greater

Proposed Rates - FY 2008

Minimum billing + \$2.52/1000 gal. over 6,000 gal. \$93.60 + 14,000. x \$2.52/1000 gal = \$128.88

Proposed Rates - FY 2009

Minimum billing + \$2.52/1000 gal. over 6,000 gal. \$112.32 + 14,000. x \$3.02/1000 gal = \$154.60
