

TOWN OF BETHEL, CONNECTICUT
INTERSECTION IMPROVEMENTS
WALNUT HILL ROAD AT HOYT ROAD

Sealed bids for the Intersection Improvements Walnut Hill Road at Hoyt Road will be received by the Town of Bethel, Engineering Department at the Clifford J. Hurgin Municipal Center, 1 School Street, Bethel, CT, 06801 until 2:00 P.M., local time, March 28, 2017 and then at said office publicly opened and read aloud. Bids submitted after this time will not be accepted. Each bidder must submit a single sealed envelope, the outside of which must be clearly marked "Intersection Improvements Walnut Hill Road at Hoyt Road."

In general, the work includes, but is not limited to, the reconstruction of a portion of Walnut Hill Road and Hoyt Road at the intersection of the roads. There will be vertical and horizontal re-alignment of the roadways, drainage improvements including ditching, a closed drainage system with catch basins and manholes and outlet pipe improvements, driveway grading, slope construction and stabilization, paving, curbing, signage and striping.

Partial sets will not be distributed.

Bidders will be furnished one PDF set of Bidding Documents. No deposit is required for the first download of PDF format Bidding Documents. Additional paper sets may be purchased. No refunds will be given for the return of additional paper sets purchased by bidders. To be considered a responsive Bidder, the Contractor shall have obtained at least one set of Bidding Documents from the Issuing Office (via the Wright-Pierce Online Plan Room). The Bid will not be awarded to a Bidder unless a record for obtaining at least one set of Bidding Documents exists in the Issuing Office. To meet this requirement and to establish the record of receipt, a prospective Bidder must obtain Bidding Documents using the name that is to appear on the Bid Form.

Prospective bidders must be prequalified with the Department of Transportation by the time of the bid.

This project will have a Disadvantaged Business Enterprise (DBE) goal of 10% of the construction contract value.

The Board of Selectman upon recommendation of the Procurement Committee reserves the right to accept and/or reject any portion of said bid; to waive any technicality in any bid or part thereof and to accept any bid as provided for in Section 8-13c of the Charter of the Town of Bethel.
